ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

PLEASE READ THE FOLLOWING CAREFULLY AND IF YOU HAVE ANY QUESTIONS, PLEASE ASK THEM BEFORE SIGNING THIS DOCUMENT.

In consideration of participating in Gunnison City's Fun Run Walk/Run/Wheel on July 4, 2023, hereafter Activity I understand the nature of this Activity and that I am in proper physical condition to participate in such Activity. I acknowledge that if I believe that conditions are unsafe, I will immediately discontinue participation in the Activity. I willingly and voluntarily agree to the following, or, if applicable, as guardian of the participant, I voluntarily execute this Agreement on behalf of my ward and agree to the following: Assumption of Risk: I understand that this Activity may be dangerous or have risks for participants. These risks may include serious bodily injury, including permanent disability, paralysis, and death, which may be caused by my own actions, or inactions, those of others participating in the Activity, the conditions in which the Activity takes place or other risks not known to me or not readily foreseeable at this time. I assume full and sole responsibility for any injuries, costs, and/or damages I incur because of my participation in this Activity.

Medical Condition: I declare that I am physically and mentally capable of participating in this Activity.

Waiver, Release, and Indemnification: I release, waive, discharge and hold harmless Gunnison City Resources and its directors, employees, volunteers, agents, other participants, Activity sponsors, and the owners of premises on which the activity takes place from any and all liability, claims, demands, action or causes of action arising out of or related to any loss, destruction, damage or injury, including death, that may be sustained by me, or any personal property belonging to me, which may result from participation in this Activity. I understand that this Agreement also binds my spouse, heirs, executors, administrators, and assigns.
