The applicant further agrees that in consideration of being permitted to use said facilities, he/she and the group will defend, indemnify, and hold the City of Gunnison, the Gunnison City Parks Department and their agents and employees harmless from any loss, claims and liability or damages and/or injuries to persons and property that in any way may be caused by the applicant's use or occupancy of the facilities. I certify that I have read, and the group will abide by the rules and regulations (See back for park rules and regulations)

RULES & REGULATIONS GOVERNING USE OF PARKS/PAVILION FACILITIES

- The permit group shall leave the facility in a clean and orderly fashion.
- No equipment or tables shall be removed from the premises or to other pavilions.
- The permit group shall agree to have at least one adult for every ten (10) minors.
- The permit group shall accept full responsibility for the conduct of those in the group using the facility
- The sale of alcoholic beverages or drugs and gambling of any kind is prohibited in all parks and recreational facilities.
- No weapons of any kind are permitted in all parks and other recreational facility
- No Pets allowed.
- No decorations shall be displayed or installed which shall damage or deface the building or grounds.
- Destruction, damage, removal of any vegetation or defacement of public property is prohibited.
- Motorized vehicles shall not be driven upon any parkland.
- A copy of this permit must be always in possession of the applicant during park use.
- No artificially enhanced or amplified sound systems are permitted without prior approval.
- No vending or sales of any kind are permitted without prior approval and copy of sales tax forms to be left at City Hall.
- No glassware of any kind is permitted.
- All park rules, regulations and ordinances of the City of Gunnison shall apply.
- Any camping or sleeping overnight in City parks is prohibited without prior approval.
- All large items (dunk tank, climbing wall, water slide, etc.) is prohibited
- A waiver must be signed to bring a bounce house into the park
